**HAVE SUMMONED**

**R F O Conferences Organizing LLC**, a company organised under the laws of the United Arab Emirates, having its registered office at Central Park Towers Floor 21, ofice [sic] 2051 DIFC, DUBAI, United Arab Emirates, having no known place of domicile or office within the Netherlands, therefore serving my writ at the office of the Officer of the Public Prosecution Service with the District Court for East Brabant at Leeghwaterlaan 8 in (5223 BA) 's-Hertogenbosch, the Netherlands, leaving copy of this summons and of the exhibits to be specified below, together with a translation into the English language with:

E.J.M. Heijmans,

employed there;

while, furthermore, promptly sending a second copy of this summons and exhibits, together with a translation into the English language, by registered post to the aforesaid domicile of the defendant;

to appear on **Wednesday, 25 January 2023, at 10:00 a.m.**, not in person but represented by counsel, at the public civil court hearing of the District Court for East Brabant, 's-Hertogenbosch location, to be held at the Palace of Justice at the address Leeghwaterlaan 8 in 's-Hertogenbosch at such time;

**GIVING NOTICE THAT:**

- A. if a defendant fails to appoint counsel or to pay the court fee referred to below on time, and the prescribed periods and formalities have been observed, the court will declare the defendant to be in default and award the claim as described below, unless it appears to the court to be unjustified or unfounded;
- B. if at least one of the defendants appears in the proceedings and has paid the court fee on time, one judgement will be delivered among all the parties that will be regarded as a judgement in a defended action;
- C. on appearance in court, a court fee will be charged to each of the defendants, to be paid within four weeks of the date of appearance;
- D. the amount of the court fees is listed in the most recent schedule to the Dutch Court Fees (Civil Cases) Act [*Wet griffierechten burgerlijke zaken*], which can be found, *inter alia*, on the website at <http://www.kbvg.nl/griffierechtentabel>;
- E. an indigent person will be charged a court fee for persons of limited means determined by or pursuant to the law if, at the time the court fee is levied, this person has submitted:
  - 1<sup>o</sup> a copy of the decision to grant legal aid, within the meaning of Article 29 of the Dutch Legal Aid Act [*Wet op de rechtsbijstand*] or, if that is not possible due to circumstances that cannot reasonably be attributed to this person, a copy of the application, within the meaning of Article 24(2) of the Dutch Legal Aid Act; or
  - 2<sup>o</sup> a certificate from the administration of the Legal Aid Board, as referred to in Article 7(3)(e) of the Dutch Legal Aid Act, which shows that this person's income does not exceed the income referred to in the order in council pursuant to Article 35(2) of that Act;
- F. pursuant to Article 15 of the Dutch Court Fees (Civil Cases) Act, a joint court fee will be levied only once for defendants who appoint the same counsel and file identical statements or put forward an identical defence;

**IN ORDER:**

on such occasion, to hear it claimed as follows on behalf of Mr Van der Heijden and BMCP on the following grounds.

**Introduction**

1. Mr Van der Heijden purchased tickets on the Internet to an event organised by RCO (s/c), both for himself and for BMCP. In this respect, an amount of EUR 28,000 was paid to RFO for participation. The invoice from RFO is submitted as exhibit 1.

2. This related to the "18th Ritossa Global Family Office Investment Summit 15-17 March 2022. VOCO Hotel Riyadh, Kingdom of Saudi Arabia".
3. Prior to the purchase of the tickets, RFO put it to Van der Heijden that:

*"350+ Elite Family Offices, Prominent Conglomerate Business Owners, Sheikhs, Royal Families, Private Investment Companies, International Business Moguls, Sovereign Wealth Funds, & industry professionals from across the Middle East and around the globe are scheduled to attend, representing over \$4.5 trillion in investor wealth and making it the world's largest and most influential gathering of elite family office decision makers, with an investor delegate ratio of 3:1."*
4. As can also be seen from the event leaflet, which is submitted as exhibit 2, and which had been sent to Van der Heijden by email.
5. Based on the offer, in which there would be more than 350 investors representing a value of \$ 4.5 trillion and an investor ratio of 3 to 1, Van der Heijden accepted the offer and purchased the tickets.

#### **Facts and circumstances**

6. On 15 March 2022, Van der Heijden was in Riyad for the event, together with 3 others, where he discovered that the agreed 350+ investors were not present, that the 3:1 ratio was lacking, and that no 4.5 trillion in investor wealth were present.
7. Van der Heijden addressed RFO's Mr Ritossa in this respect and corresponded with him by WhatsApp and by email. The WhatsApp correspondence showing that RFO was already willing to compensate Van der Heijden is submitted as exhibit 3.
8. Van der Heijden did not settle for this and demanded that RFO compensate the costs incurred by him.
9. Unfortunately, this has not resulted in reimbursement of the costs, and Van der Heijden has been forced to pass on the claim to their counsel for collection and, after RFO had been sent a demand letter, initiated these proceedings. The correspondence relating to the demand letter is submitted as exhibit 4.

## Legal framework

### Error

10. It sufficiently follows from the foregoing that Van der Heijden had based his decision to enter into the purchase agreement for the tickets on an incorrect assumption of the facts.
11. He would never have purchased the tickets had he known in advance that only a small portion of the 350+ investors, as put to him by RFO, would be present. The fact that only a marginal portion of the investors were present can be confirmed, *inter alia*, by the witnesses and other participants in the event.
12. The claimants seek nullification of the agreement and repayment of the tickets paid for in the amount of \$ 28,000, as well as damages.

### Breach of contract

13. In addition, there has been breach of contract on the part of the defendant. With its event, the defendant did not deliver what it had agreed with the claimants. For that reason, the claimants seek repayment of the tickets paid for by them as well as damages.

## Defendants' position and rebuttal thereof

14. The defendant seems to acknowledge that there has been error or default, since it has offered a 'refund' to the claimants.
15. The defendant has only responded through its counsel and only bluntly stated that this was slander. It has not given any substantive response to the claimants' letters. These letters are submitted as exhibit 5.

**Offer to produce evidence**

17. To the extent that this Court should hold that any burden of proof lies with the claimants, the claimants offer to produce evidence of their statements by all lawful means, including hearing witnesses.

**Jurisdiction**

18. This Court has jurisdiction to hear this matter, since neither a choice of forum nor a choice of law had been agreed between the parties, and the purchase agreement for the tickets was entered into on the Internet, Mr Van der Heijden being deemed to be a consumer.

**THEREFORE:**

this Court is respectfully requested, in its decision, provisionally enforceable to the extent possible:

- I. to reverse the consequences of the purchase agreement on the basis of error, ordering the defendant to pay an amount of EUR 28,000 as well as the damages, estimated at EUR 25,000, in order to remedy the harm caused to the defendants (*sic*) as a result of the error, as described in the body of this summons, to be increased by the statutory (commercial) interest;
- II. to consider the purchase agreement dissolved, ordering the defendant to repay the purchase price of the tickets in the amount of EUR 28,000 and to pay damages in respect of the costs incurred by the claimants, estimated by them at EUR 25,000;
- III. to order the defendants to pay the costs of the proceedings, including the fees and the necessary disbursements incurred by counsel for the claimants, to be increased by the (subsequent) costs, all to be paid within fourteen days of service of the judgement and - to


the extent that payment of the (subsequent) costs is not made within the term set - to be increased by the statutory interest thereon from the fourteenth day following service of the judgement.
